- 8. Evangelism Proven ability to share the Gospel, nurture spiritual growth in others, and have a passion for the youth.

- Applications must be signed and reach the North West Trinidad District Office by 4:00 p.m. on February 03, 2025.
- All suitable candidates will be required to attend an <u>initial</u> interview with the District Executive, together with their spouse, from which a short-list will be established.
- Short-listed candidates will be required to attend an interview with representatives of the Church Board (overseen by the District Executive).
